GENERAL CONDITIONS TO BE FULFILLED BY ALL COURSES

1. That they should appoint teaching staff @ 1:12 through duly constituted selection Committee as per P.U. norms, associating the University Nominee on the selection Committee and Subject Expert representing all Methodologies and obtain the Renewal/Approval of the Registrar, Palamuru University for the Non - ratified staff at the beginning of the Academic Year whenever required.
2. They should run the course in two sections of (50) each where the accommodation for (100) students are not available.

1. To provide spacious rooms for classes and laboratories and separate toilets for Men and Women as suggested by the Inspection Committee.
2. Consolidated attendance statement is to be prepared every year and submit to the University.
3. It is made clear to all the colleges that Non fulfillment of the above conditions by the College(s) within the stipulated time, such college(s) will be disaffiliated after intimation to NCTE /State Government.
4. To appoint a qualified librarian.
5. Attendance register and teaching diaries are to be maintained properly. Attendance of the students to be marked in the class room only.
6. Colleges should strictly adhere to Palamuru University almanac.
