

- (IX) Quorum: Half of the total members for general body meeting and $\frac{1}{4}$ for executive body meeting.
- (X) Funder: The Funds shall spent only to the attainment of the objects of the Society and no portion thereof shall he paid or transferred directly or indirectly to any of the member through any means.
- (XI) Amendments: No amendments or alternation shall be made in the purpose of their association unless it is voted by 2/3 of its members present at a special meeting conveyed present at second special meeting.
- (XII) Winding Un : In case the Society has to be wound up the properly and funds of the society that remain of the discharging the liabilities if any shall be transferred or paid to some other institution with similar aims objects.
